PUBLIC COMMENT:

Senior Services Committee Chairman Patrick Brazill announced the resignation of a member of the committee and noted that there were not enough members to have a quorum. Supervisor Jaeger suggested that the committee modify its by-laws to allow for a smaller number of members present to have a quorum. It was suggested that an advertisement be placed in the local newspapers to find persons interested in serving on the committee. Patrick Brazill noted that a newsletter is to be ready in March.

Senior Program Proposal: Debra Quackenbush, a consultant, presented a plan for developing a five year program at the Geneva Township Senior Center. Supervisor Jaeger asked the trustees to review the materials and be prepared to consider the proposal at the March Board of Trustees Meeting.

ELECTED OFFICIALS REPORTS:

Assessor Aubrey Pratte announced that there had been 965 sales in 2004. Supervisor Jaeger said that the intergovernmental agreement with the Geneva Park District had been signed by both parties. He planned to meet with City of Geneva officials to obtain the necessary permits for the remodeling project at the Wheeler Park building.

The new system will be tested on a few people before beginning the full program.

No other business was brought before the Board of Trustees. Motion by Trustee Sharp/second by Trustee Brazill to adjourn. Motion carried. Meeting adjourned at 7:35 p.m.
