## **CONTINUED MEETING**

Supervisor Patrick Jaeger called the continued meeting to order at 7:10 p.m. Trustee John Connolly led the Pledge to the Flag. Clerk Barbara Olson called the roll.

SETTING SALARIES FOR OFFICIALS TO BE ELECTED AT THE 2013 ELECTION: (DISCUSSION ONLY)

Discussion ensued regarding insurance coverage for elected officials. One suggestion was to establish a step system where 1<sup>st</sup> year premium is 5%. 2<sup>nd</sup> year is 10%, 3<sup>rd</sup> year is 20%, and after that the township would pay 70%. Trustees questioned whether the same provisions might apply to township employees and whether insurance coverage would be offered to all part time elected officials.

Supervisor Jaeger stated that all elected officials are considered part time

except for the assessor's position.

Trustee Connolly Sussested family health insurance coverage be included in the assessor's coverage Township Contribution Could be 60 70

Trustee John Connolly asked that the highway commissioner and the supervisor provide some documentation as to how many hours they work for the township and the kind of work they provide to the township.

Trustee Kovacs suggested eliminating all insurance for elected officials and to offer a salary attractive enough for the position.

Trustee Kovacs thought the salaries for the clerk and supervisor positions were adequate for the next four years. He also suggested a COLA increase for the assessor's office.

Trustee Kovacs suggested a \$15,000.00 per year salary plus insurance for the supervisor and \$12,000.00 per year salary for the clerk with no insurance. A salary of \$75,000.00 plus insurance was considered for the assessor's position. It was suggested that a salary of \$27,000.00 plus insurance be considered for the highway commissioner's position.

After further discussion, Supervisor Jaeger summarized some of the ideas to include the following:

Corrected

Added Sentence 10-18-12 he Assessor: \$75,000.00 annual salary plus a contribution in a four step insurance program.

Highway Commissioner: Trustees asked for a report from the current highway commissioner regarding hours worked and callouts. At present a salary of \$10,000.00 to \$27,000.00 was considered.

Supervisor: \$15,000.00 annual salary. Trustees asked for a report from the current supervisor regarding hours worked. Health insurance could be offered to the position of supervisor.

Clerk: A salary of \$12,000.00 per year with no health insurance benefit.

This Board of Trustees Meeting was for discussion purposes and no decisions were made regarding the setting of salaries.

No other business was discussed at this meeting.

Motion by Supervisor Jaeger/second by Trustee Connolly to close the meeting Motion carried.

Meeting adjourned at 8:25 p.m.
