#### **TOWNSHIP BUSINESS:** ·

ORDINANCE #04-12 ROAD DISTRICT TAX LEVY ORDINANCE FOR 2012

Motion by Trustee Connolly/second by Trustee Brazill to pass Ordinance #04-12 in the amount of \$290,500.00. There were questions regarding the low levy amounts in several funds. It was noted that some road district fund amounts are carried from one year to the next.

Motion by Trustee Kovacs/second by Trustee Brazill to amend the motion to correct the day and month of the levy to December 20, 2012. Motion carried. Motion by Trustee Connolly/second by Trustee Brazill to pass Ordinance #04-12 as amended. Motion carried unanimously.

#### **ORDINANCE #05-12 TOWNSHIP LEVY FOR 2012**

Motion by Trustee Kovacs/second by Trustee Connolly to pass the levy of \$680,763.00 for 2012.

Supervisor Jaeger asked the trustees to amend the levy to make the 2012 levy the same as the 2011 levy.

Motion by Trustee Brazill/second by Trustee Sharp to amend the 2012 tax levy to \$658,080.00.

Supervisor Jaeger asked the trustees to authorize him to sign the site agreement for 2013 with the same conditions as the 2012 agreement. Motion by Trustee Kovacs/second by Trustee Sharp to authorize Supervisor Jaeger to sign the agreement as presented. Motion carried unanimously.
