- 1. Resolution to Levy Funds for Road District Capital Projects. Motion by Trustee Brazill / second by Trustee Connolly to approve the Resolution as presented. Motion carried unanimously. Motion to amend and correct the title from "Ordinance" to "Resolution" for the Resolution to Levy Funds for Road District. Motion by Connolly / second by Trustee Brazill. Motion carried unanimously.
- 2. Resolution to Levy Funds for Center Capital Project. Motion by Trustee Connolly / second by Trustee Queen to approve the Resolution as presented. Motion carried unanimously. - 3. ORDINANCE #14-13 ROAD DISTRICT TAX LEVY ORDINANCE FOR 2014. Motion by Trustee Sharp/second by Trustee Connolly to pass Ordinance #14-13 in the amount of \$303,637.00. There were questions regarding the low levy amounts in several funds. It was noted that some road district fund amounts are carried from one year to the next.
- 4. ORDINANCE #14-12 TOWNSHIP LEVY FOR 2014. Motion by Trustee Brazill/second by Trustee Queen to pass the levy of \$691,091.00 for 2014. Supervisor Jaeger asked the trustees to amend the levy Page 3 to correct commodities total from \$11,145.00 to \$19,013.00. Motion by Trustee Connolly / second by Trustee Sharp to amend the 2014 tax levy total Commodities to \$19,013.00. Trustee Sharp did note he does not want to increase any taxes or levy's.
