He also wanted to make sure we knew that there are no sidewalks and no streetlights – could lead to a mess if the road is connected. William also asked if the City of Batavia has the right to annex over the Township. Mr. Jaeger answered that question and informed them they do have the right to do so. Mr Abts informed the public that we are fighting for them. He has reached out to and is working with Counsel for the best way to address all concerns and options for us now. Hoping to hear something in the next week and address with the city of Batavia.
