#### AN ORDINANCE FOR THE LEVY OF TAXES FOR ALL ROAD DISTRICT PURPOSES OF THE GENEVA TOWNSHIP ROAD DISTRICT, KANE COUNTY, ILLINOIS FOR THE TAX YEAR 2020 TO BE COLLECTED IN 2021

#### BE IT ORDAINED BY THE TRUSTEES OF THE TOWNSHIP OF GENEVA, KANE COUNTY, ILLINOIS, as follows:
